As of today, April 28, 2018, I call for the nominations of five State Administrative Committee Members. The positions which will be up for reelection this year are the South Rep, the East Rep, the Compulsory Athlete Rep and the Optional Athlete Rep. We have added a Secretary back in on the Committee as we have been without one for the past year. The position descriptions and criteria are as follows:

East Sectional Rep – 2-year term

- Actively coached for the past 5 years at a Washington State Club.
- Coached at a Sectional, State or Regional meet in the past 3 years.
- Must work within the East Sectional boundaries.
- Assumes responsibility to communicate with all Club owners, coaches and judges in your Section.
- Communicates closely with the Athlete Reps.
- Must be present at the East Sectional Championships.

South Sectional Rep – 2-year term

- Actively coached for the past 5 years at a Washington State Club.
- Coached at a Sectional, State or Regional meet in the past 3 years.
- Must work within the South Sectional boundaries.
- Assumes responsibility to communicate with all Club owners, coaches and judges in your Section.
- Communicates closely with the Athlete Reps.
- Must be present at the South Sectional Championships.

Optional Athlete Rep – 2-year term

- Actively coached for the past 5 years at a Washington State Club.
- Coached at Westerns and/or Nationals for the past 3 years.
- A current Optional level Coach.
- Assumes responsibility to communicate with all Club owners and coaches on business pertaining to Optional athletes.
- Assist Educational Rep with the planning of State Congress.
- Must be present at Optional State Championships.
- Represents Washington State at Regional High Tech and Super Camp.
- Coordinates at least 2 Washington State Level 9-10 workouts throughout the year.

Compulsory Athlete Rep – 2-year term

- Actively coached for the past 5 years at a Washington State Club.
- A current Compulsory level Coach.
- Assumes responsibility to communicate with all club owners and coaches on business pertaining to Compulsory athletes.
- Assist Educational Rep with the planning of State Congress.
- Must be present at Compulsory State Championships.

State Administrative Committee Secretary – 2-year term

- Actively involved in USA Gymnastics Washington for the past 5 years.
- Has served on the USA Gymnastics Washington State Administrative Committee for at least 2 years.
- Assumes responsibility to take minutes at all State Administrative Committee meetings.
- Assumes responsibility to track all athletes for mobility and post season competitions.

Per Operating Code, State Administrative Committee members must be a minimum of 21 years of age and active in our state's program.

Nominations will close on May 14th, 2018. Candidate statements will be posted online and elections will be held online from June 1st to June 15th, 2018. Newly elected officers will begin their term August 31st. More information on this procedure will follow.

The nomination form is attached below and should be mailed to me c/o Emerald City Gymnastics Academy. Please make sure I receive all nominations by May 14th, 2018. If there is only one qualified nominee for any position, I, as the State Chairman will cast one vote and no general election will be necessary.
